EXECUTIVE LETTER

2018 ANNUAL REVIEW

Dear Friends,

In a world filled with challenges, Consolidated Cooperative's trustees and employees are tightly focused on the organization's core mission: bringing affordable, reliable, and safe quality-oflife services to you and your communities, when other businesses and organizations can't or won't. It is the only reason we exist; it is our privilege, therefore, to provide an overview of how your cooperative has continued with and improved on these goals in 2018.

Strength in Numbers

Consolidated lights up lives with electric-power services to roughly 14.000 members and 17.000 meters in north-central Ohio over 1,870 miles of power lines. Every year, we study our costs of providing those services and in 2018 identified a need for additional revenue to cover our increased expenses for the first time since 2014. The new electric rates took effect January 1, 2019, and will provide financial strength and flexibility now and into the future so we can continue helping our communities thrive and our members prosper.

We also light up members' lives with gas services — including 793 natural-gas meters and 2,746 propane accounts. Our commitment to excellent service, reliable delivery, and affordable pricing has allowed us to continue adding gas customers consistently over the past twenty years.

Although your and your neighbors' parents and grandparents created the co-op more than 80 years ago with an eye on making life easier and better with electric power, today we're the first electric co-op in Ohio to bring its members what is arguably the fastest-growing need for access to products and services that are so rapidly redefining quality of life; we are lighting up broadband internet service that not only meets or exceeds today's needs, but easily adapts to the imminent future. We expect to roll out broadband internet to the entire membership over the next four years, and we have expanded our workforce to build out our fiber-optic system and support this new service. We're excited, and we know you are, too, because you tell us.

Pioneers

Ask Ryan Boyles, a member whose family relies on the internet for online classes and for Ryan's work. He put his enthusiasm to work by recruiting his neighbors to sign up for service and is now enjoying the fruits of his labor — speeds that equal or better those available in more populated areas and include our unmatched service. Ryan is a great example of what a cooperative is at its core — its members working together to accomplish something that will impact the community positively well into the future.

High Marks

Ryan wasn't the only member to weigh in about Consolidated Cooperative's services last year.

In our 2018 Member Attitude Survey, you resoundingly said you're happy with us. You rated us an average 8.79 out of 10, an increase of 0.3 over last year. You especially appreciated our communication efforts, and told us that those efforts show we have members' best interests at heart.

Studies show that overwhelmingly, people want their work to make a difference and want to be recognized for what they do. We, your cooperative's employees and trustees, love knowing that our efforts help make life better for people, and that the people we serve recognize our diligence.

Thank you for investing some of your time and interest with us; we look forward to seeing you at the annual meeting on May 18 at the co-op's Delaware location.




GAS

Residential




GLANCE AT 2018

The cooperative recognized net margins of \$2.3 million in 2018. The increase in margins over prior years were primarily due to a return to "normal" weather, after several years of mild weather, and an increase in net margins received from the wholesale power supplier in the form of capital credits.









WE WATCH WHAT WE SPEND

Consolidated Electric paid wholesale power costs of \$28.6 million in 2018. The cost of power amounts to 62% of the total cost of providing electric service to members.





CONSOLIDATED FIBER









CONSOLIDATED GAS

The number of members continues to grow, for both gas service lines, as homes are being built in the area and residents look for high quality and competitive prices from their gas provider.









GAS SALES
